Tangled Feet hold a unique place in the British theatre landscape: a physical theatre ensemble, with a 15-year history of making ambitious performances both inside and outside of theatre buildings, running integrated, innovative participation programmes with diverse young people and championing ensemble theatre making. The

company has been based in Luton since 2017.

We make uniquely staged, story-driven theatre. We have a trademark style of experimental, bold and accessible performance, inspired by our own experiences, the stories of under-represented groups, and the tensions we feel in the world.

We consistently share the creative process with new people, as an integral part of our production process and in workshops, residencies and targeted participation projects. We have specialist knowledge of working with young people with a range of additional needs who face social disadvantage. We create routes through to professional practice for young people who might struggle to begin a career in the arts.

- We advocate for opportunities for young people to change the world and for their right to be seen as significant

- We create a space where we can form empathetic connections with each other; sharing stories and narratives in public spaces to bring us closer together

- We simultaneously entertain, challenge and delight; we create lasting memories and inspire other artistic journeys.

Tangled Feet is an ensemble of artists but is led by a Senior Team of Nathan Curry and Kat Joyce (Co-Directors), Jonathan Ellicott (Development Manager), Mario Christofides (Finance Manager), Alyson Jones (General Manager) and Emily Eversden (Participation Manager) who all work parttime.
